Duration of Empanelment: Consultants/ Engineers will be empaneled initially for 2 years which can be further extended on satisfactory performance and mutual agreement till upper permissible age limit of 65 years.

Medical Health Condition: Empaneled Consultant Engineer/ Professional shall be in good health and physically and mentally fit to be entrusted with any of the assignments of CEIL. They are required to submit Medical Fitness certificate in the prescribed Format at the time of initial empanelment.

Process of Empanelment: Empanelment will be done with due review & verification of candidate's document and interview.

Assignments: During the period of empanelment, Empanelled Consultant Engineers shall be entrusted with any assignment of CEIL's areas of operations/job requirements suiting their experience profile. They may also be required to work on offshore installations & pipeline sites. The duration of any assignment may vary from few days to weeks or months. Normal duty is considered 8-10 hours a day. No additional fees are payable for the extended working due to requirements of a particular job.

CEIL Project Coordinator shall coordinate the job assignments.

During the period of empanelment, CEIL expects an efficient and result oriented performance of high standards.

He/She shall endeavour to complete all assignments within the agreed time schedule. Refusal to accept an assignment without any valid reason may amount to automatic termination of empanelment.

Remuneration: CEIL will pay the Empanelled Consultant Engineers/ Professionals remuneration (**Fees**) as per the approved rates by the Company for various Categories of Consultant Engineers/ Professionals.
